- 4) Committee Reports.

 - b. Beautification The Beautification Committee is having the exterior of the Community Building painted blue. The TI logo will be on the outside Tom Chaffee and Gayle Pendergrass are donating a large palm tree to Civic. Jim Coursey may be able to move and plant it.
 - c. Election Committee All current Board Members will not be running for election. This means we will have no returning Board Members and will need 7 people to agree to run. Based on this, the election Committee made a change to the Election timeline to allow the Community to respond to multiple requests via email for Candidates. Gerry Henderson asked for Volunteers from the attending audience and there were three interested parties. In the meantime, the Committee requested that we get an opinion from our Attorney on what the ramification is for not having the required 5 members as is stated in the By-Laws to be reviewed at the next meeting. - d. Architectural Control The Architectural Committee reported one new permit for the last period. The permit was approved. A motion was made Kym to adopt the new form for building permits to be effective April 15, 2014. The motion was seconded by Julie. - e. Deed Restriction and By-Laws The Deed Restrictions Committee has determined the fireworks stand on Bluewater Hwy next to the beach side entry is not part of TI. They have contacted the Corp of Engineers to determine if stand is in the wetlands. This case is open. DRC has also contacted the County about the property being valued at \$120.00.
- f. Election Committee The Election Committee has put together a timeline for this year's election of Board of Directors. See attachment
- 5) Management Company Discussion. . A Team of Gerry, Dan Rudroff, Kym, Mike Cooper and Les Seibert was assembled to investigate various property management firms.
- 6) TIMUD Easement Request Kym made a motion to allow John, as President, to negotiate and execute an easement agreement with MUD to release Civic of liability. Motion was seconded by Gerry. The vote was John, Tom, Kym, Julie, Karen and Gerry for and Ginny against. Motion passed.
