At the Executive Meeting, the BOD discussed a request from a resident desiring an e-mail be distributed to all residents concerning contractors and lawn maintenance companies not commence work before 8:00 am. An e-mail will be sent out as a request to residents since this action is difficult to enforce.

New business was discussed next. A resident expressed concerns regarding the lack of a "no-wake" sign on the canal side of the community. Don Riehl will look into this issue and report back to the Board. Also, the lots that Mr. Llewellyn owns and is wanting to sell is an ongoing matter.

The next order of business was the Open Forum. Sheryl Kuhfeldt asked the BOD whether recycling bins for TI residents were possible. TIMUD is essentially responsible for this area and this issue will be referred to them for future information on this subject. Gary Shankle asked for the name of the liaison for trash pick-up in Brazoria County. Gary is concerned that the trash that is on the ground next to the receptacles is not being picked up by the county. Ken Foyt mentioned that several TI residents do pick up this trash that the county leaves behind.

There being no further business, a motion was made by Bunny Vitasek-Arcoria and seconded by Lyn Dodson and unanimously approved to adjourn the meeting at 10:21 am.
