UPDATE 1: GRANT APPLICATIONS

- National Fish & Wildlife Federation – Coastal Resiliency Fund -- Stage 1 Pre-Proposal: Treasure Island Assessment for Community Resiliency
 - Pre-proposal submitted on April 7!!
 - In general, the long term goals align with the Texas Coastal Resiliency Plan (beach and dune stability, coastal storm risk management, rookery island enhancement, watershed planning, and wetland protection and shoreline stabilization). Intended outcomes of this Assessment are:
 1. An effective, sustainable resiliency plan for community and wildlife preservation
 2. Re-establishment of functional dunes to support abundant wildlife, and protect the community infrastructure from higher high tides.
 - Next Step: NFWF notification is accepted to submit full proposal – Mid May 2021

UPDATE 1: GRANT APPLICATIONS

- CEPRA Cycle 12: San Luis Pass Erosion/Nourishment/Beach Stabilization/Revetment Project
 - Submissions due June 9, 2021
 - In process of pulling together materials for this submission
 - May require assistance from an engineering firm to ensure a successful submission – MottMacDonald is amenable and estimates costs for their services around \$10k
 - Next Step: Confirm available funding and seek Board approval to proceed

- Engineered solutions (water pumps) are multi-million dollar investments
 - TI would purchase and maintain all the pumps and equipment
- Next steps: Follow-up with BakerLawson and ensure we've answered the questions for the community
