FIRST AMENDMENT OF THE BY-LAWS OF

SAN LUIS PASS RESORT COMMUNITY CIVIC ASSOCIATION

Let it be known that according to Article X. Amendments: The by-laws of this corporation may be amended, repealed, or added to, or new by-laws may be adopted by the vote or written assent of a majority of the members entitled to vote or by the vote of a majority of a quorum at a meeting duly called for the purpose according to the articles or by-laws. According to Article III, Section six of the by-laws the members holding ten percent (10%) of the votes that may be cast at any meeting shall constitute a quorum at such meeting. After notice to the members on February 19, 1978 a members meeting was held for the purpose of election and the amendment of the bylaws. The members voted by a majority vote of a quorum the following amendments of the bylaws:

RESOLVED THAT, the Bylaws be amended to reflect the following change:

ARTICLE III Meeting of Members

Section One. Annual Meeting. The original bylaw to be deleted and replaced with: An annual meeting of the members shall be held at a location to be designated by the directors on the second Saturday of the month of June each year, beginning with the year 1979, at the hour of- 12:00 o'clock noon, for the purpose of electing directors and for the transaction of such other business as may properly come before the meeting. If the election of directors shall not take place on the date designated herein for any annual meeting, or at any adjournment thereof, the board of directors shall cause the election to take place at a special meeting of the members to be held as soon thereafter as may be convenient.

ARTICLE III Meeting of Members

Section Eight: MANNER OF ACTING. The original bylaw to be deleted and replaced with: The act of a majority of the members present at a meeting at which a quorum is present shall be the act of the members, unless the act of a greater number is required by law or by these bylaws.

ARTICLE IV Board of Directors

Section Two: NUMBER, TENURE, QUALIFICATIONS: The original bylaw to be deleted and replaced with: The number of directors shall be seven (7). Each director shall hold office until the next annual meeting of members or until his successor shall have been elected and qualified. Directors must be full members of the corporation.

Approved on the 19th day of February, 1978

Nov. 5, 1977 (SPECIAL CALL MEETING)

Architectual board nominated Mr. George Mort to fill the vacancy on the board.

R. Hyatt appointed nominating committee for coming election in February.

Paula Carroll suggested we increase the number of board members from 5 members to 7 members. R. Hyatt was to check with R. Frahm to see the exact proceedure we needed to follow to be in agreeance with our By-laws.

Mr. W. Brown O.K'ed fencing of his property by KOA side and J. Stevens was to let us know the legality of doing this. C. Hottman was to get a map showing road plot.

- G. Mort was to check the complexity of fencing the entire area.
- C. Hottman was to appoint MUD representative (J. Leonard) on legality of drainage ect.

Board authorized paying for light on 3rd canal by J. Spicers property since there was no lighting in this area.

The Civic Association Tax Free # T-900 was to have been issued 12/76 and will be due again in May 78.

- R. Hyatt was to check with Larry Ham to see if actually filed, when and how. R. Frahm was to check and see if wee need to file now.
- J. Stevens letter stated we could not bence area by KOA.

Meeting adjourned.

December 10, 1977

This motion will have to be resubmitted at the Feb. meeting for vote of majority of members. A voters proxy will be mailed to each member

The nominating committee stated they had ample nominees to fill the new number on the board.

Ed Spicers light (3rd canal) had been applied for and will be 2 or 3 months before complete.

It was recommended we have a study committee to find the lighting needs for entire area. Nita Cade was asked to serve in this capacity. At the present we are paying for the operation of 7 or 8 lights at the cost of \$3.50 per light.

Mr. Geo. Mort was to contact Mr. F. Placke (KOA) on garbage truck parked on lot owners property.

R. Hyatt to call J. Stevens and have him file suity on P. Slater property.

Reminder of letter to property owners on annual meeting and to include proxy as stated in By-Laws . Also vote on change of time and date of annual meeting.

Meeting in Feb to be held at 11:00 a.m. prior to annual meeting at 2:00 p.m. Feb. 19.
